RDO Shipment Quality

- **Poor** - consolidated shipment, poor item mix (heavy & fragile), with minimal or no packing
- **Better** – consolidated shipment, good item mix (like items), adequate packing
- **Best** – individual item packaging and individual packing



Poor Packing



Heavy items packed with fragile and light items. Requires proper packing to protect RDO items



Contents too heavy for shipping box



Lower boxes unable to support weight from above



Item not packaged, insulator broken during shipment





Poor Shipment Summary

- Pictures show a Consolidated shipment with:
 - Poor Item Mix; Heavy items packed with fragile and light items
 - Minimal or no packing
 - RDO identification (as required) OMITTED
 - Exterior cartons unable to support content weight
- **RDO PACKING POINTS TO REMEMBER**
 - **Large or small, Fragile or not, Items REQUIRE proper packing for protection**
 - **REQUIRED RDO identification is, RDO#, NSN, Quantity**



Better Packing Examples

- **Consolidated Shipment Smaller and Lighter**
 - Individually bagged / boxed,
 - Labeled as required w/ RDO#, NSN, Quantity
 - Larger items require additional protection
 - Packed with proper cushioning inside shipping box
 - Consolidated Packing Slip (PS) REQUIRED - 2 outside, 1 inside
 - USAF WWRS RETURN label (optional)
 - Shipping address and US Customs statement (as REQUIRED per page 18 of WWRS Handbook)



Better Packing



Smaller and Lighter items individually bagged and labeled w/ RDO#, NSN, Quantity (as required)

Smaller and Lighter items consolidated and packed with proper cushioning inside shipping box



Consolidated Items properly packed w/ Consolidated Packing Slip (REQUIRED) and USAF WWRS RETURN label (optional)

Better Packing Summary

- **Consolidated Shipment**
 - Like ITEMS, Smaller and Lighter
 - RDO's packed for individual protection large or small
 - Individual RDO's bagged or boxed
 - Individual RDO's labeled w/ RDO#, NSN, Quantity (as required)
 - Over packed with packing in shipper box for RDO item protection and safe shipment to IIP
 - Consolidated Packing Slip (PS) RDO#, NSN, Quantity, FMS CASE, Total Value (as required)



Best Packing Examples

- Consolidated RDO Shipment Individually boxed w/consolidated packing slip
- RDO Individually boxed with 1348 documentation





BEST Packing Summary

- Consolidated RDO Shipment Individually boxed w/consolidated packing slip
 - Packing slip (PS) copies 2 outside, 1 inside shipping box
 - **AT MINIMUM info MUST CONTAIN – RDO NUMBER, NSN, QUANTITY, FMS CASE, and TOTAL SHIPMENT VALUE**
- RDO Individually boxed with 1348 docs
 - 1348 copies; 2 outside, 1 inside
- **Packing Tips to Remember**
 - **MINIMUM info required on Consolidated Packing Slips (above)**
 - **PS and 1348's require 2 outside, 1 inside**
 - **When stretch wrapping skid shipments it is always a good idea to have a master packing slip and 1 additional copy of all 1348's for US CUSTOMS**



IIP RDO Shipment Receipt

- Digital picture of received package / packages
- Manual recording of shipment
 - Received picture #, date, weight, measurements of shipment, cube, and unique shipment receipt number, electronic recording of shipment
- Electronic recording of shipment
 - Received picture #, date, measurements, weight, cube, picture #, unique IIP box receipt #, packing slip #, carrier, waybill number, original ship date, pieces and weight



RDO Inspection Criteria

- Evaluation of RDO Packaging
- Correct / Acceptable NSN / PN verification – MFR cage (as applicable)
- Visual inspection for appearance of Serviceability, Contamination, and Damage
- Documentation of Serial #'s and/or Shelf Life criteria
- Sanitization of Foreign markings




