Step 1: Establish Account

Step 2: Establish Sales Criteria

Steps to Become a Seller

Step 1: Establish Account

- **Submit LOR for WWRS Q-Case**
 - **Case value = 8.5% of materiel value to be transferred**
 - **Terms of Sale: Cash with Acceptance, Balance as Billed**
 - **Cash with acceptance: Seller provides initial deposit equal to 5% of line value, plus half of administrative surcharge (1.9% / 1.75%) = 6.9% / 6.75% depending on when case was created**
 - **Balance as Billed: Subsequent funds will be billed as actual redistribution occurs**
- **Appoint country WWRS Point of Contact (POC)**
 - **Primary & Alternate**



Steps to Become a Seller

Step 2: Establish Sales Criteria

- **Country WWRS POC will:**
 - Request an AFSAC Online user name and password (DD Form 2875, can be found on AFSAC online; <https://afsac.wpafb.af.mil/>)
 - List inventory and perform materiel queries
 - Establish minimum order value (MOV)
 - Establish automatic price adjustment authority for seller selection
 - Manage Monthly Activity Reports
 - Coordinate WWRS materiel movement



Steps to Become a Seller

Step 3: Determine Eligible Materiel

- **Materiel must meet following criteria:**
 - **Fully Functioning (Non-Significant Military Equipment)**
 - **USAF, USA, NAVY, or DLA Managed**
 - **Purchased under Arms Export Control Act (AECA)**
 - **Unclassified**
 - **Non-Explosive**
 - **Non-Ozone Depleting Chemicals**



Steps to Become a Seller

Step 4: List Materiel

- **Country WWRS POC submits inventory of items**
 - Directly using AFSAC Online account
 - Email large data set to PMO for upload
- **Three formats for listing items**
 - NSN info only, NSN & part number info, NIIN & Part number, noun & CAGE Info
- **Updates must be submitted using same format**
- **Reference: WWRS Users Guide, Appendix A**



Steps to Become a Seller

Step 5: Sell Materiel

- **WWRS POC receives Redistribution Order (RDO) Notices**
 - Verifies materiel availability
 - Provides time to ship
 - Receives notice to ship materiel
 - Ships materiel to WWRS In-transit Inspection Point
 - Receives Inspection Results (negatives only)
 - Monitors Activity Reports
 - Monitors Financial Reports



Steps to Become a Seller

Step 6: Receive Proceeds

- **Invoice created for WWRS shipments (month end)**
- **Seller's materiel value collected from Buyer and deposited into WWRS clearing account**
- **Funds from clearing account segregated by Seller and deposited into Seller's WWRS cash holding trust fund account (CC-Q-6QX)**
- **Seller WWRS case (CC-D-QXX) charged fee associated with materiel shipped during that month**



Steps to Become a Seller

Step 6: Receive Proceeds (Continued)

- **Funds transferred from CC-Q-6QX to cover fees against CC-D-QXX (deposited as though Seller made scheduled payment)**
- **Funds remaining in CC-Q-6QX are available for withdrawal and/or transfer to another FMS cash case**



Comments

- **Steps 1 – 3 can be worked concurrently**
- **Steps 4 – 6 can not be done until a case is signed and the initial deposit is received at DFAS**



WWRS FEES

- **WWRS goal, like all FMS programs, is to be self-supporting with neither profit nor loss**
- **Fees reviewed bi-annually(next review Apr 2012)**
- **WWRS Fees (Paid by seller)**
 - **Funds WWRS personnel and admin cost**
 - **In-transient Inspection Point (IIP) service – contracted**
 - **Automated Data Processing (ADP) - contracted**
 - **Programmer - contracted**



WWRS Fee Structure

Implemented 1 Jan 11

**WWRS Fee: 8.5% of the extended value to be sold
or \$200...which ever is greater**

- \$40,000 maximum fee

**Discount for Seller initiated lot transfers of at least
20 line items**

<\$100,000	7.65%	(10% reduction of WWRS fee)
>\$100,000	6.8%	(20% reduction of WWRS fee)

**No additional charge to buyers for routine ground
transportation (<\$100)**



WWRS Fee Structure

Implemented 15 Mar 12

\$13 charge to seller for all items arriving at IIP on Wood Packaging Material (WPM) that is not compliant with International Standards for Phytosanitary Measures (ISPM) 15, *Guidelines for regulating Wood Packaging Material in International Trade*

This fee is used to recover costs associated with proper disposal of non-compliant WPM that is received

No additional charge to buyers for routine ground transportation (<\$100)
