We are pleased to announce the 10th annual Worldwide Warehouse Redistribution Services (WWRS) Program Management Review (PMR). The PMR will be 20-22 May 2015 at the Drury Inn, Dayton Ohio. SAF/AA Air Force Policy Update dated 13 Dec 13 states FMS events like our PMR that are entirely funded with Foreign Military Sales (FMS) funds to be exempt from the conference policy approval process. We respectfully invite all FMS partners and DoD FMS employees/contractors to attend this event.

The first day of the PMR will be a plenary session in which briefings will be presented on items you ask for and suggested subjects. There will also be a field trip to the In-transit Inspection point where all WWRS items are inspected, processed, repackaged and forwarded to the buyer.

We will be holding a hands-on Buyer/Seller training workshop on day two where our logistics professionals will demonstrate our new website and teach you how to run reports and upload/modify inventory (bring your laptops/user name and passwords). This hands-on training workshop is specifically built for FLOs, SALOs, SAFRs, and in country POCs that accomplish the daily WWRS transactions although everyone is welcome to attend. Day two also starts our bilateral (1 hour) meetings with our selling/buying partners and any other interested FMS customers. Day three will continue our hands-on Buyer/Seller training workshop and bilateral meetings.
